Gynecologist monitors practice performance with Quantum EHR, PM

Sherri Beasley is the office manager at Dr. Michael Barnthouse's office in Kansas City, Missouri. Dr. Barnthouse practices gynecology, delivering personalized and comprehensive health care for women at every stage of life. He has been in business in the region for over 35 years. Challenge

In early 2013, the practice was preparing to transition from paper charts to electronic health records (EHR). At the time, they did not have enough Medicare patients to report for government regulatory and incentive programs, but they knew it was time to modernize by going electronic.

Solution

Given that their Medicare population is growing, the practice plans to use the EHR to help report for the Merit-based Incentive Payment System (MIPS), which is part of the Medicare Access and CHIP Reauthorization Act of 2015 (MACRA). Because the Quanum EHR is fully certified to meet the associated CMS regulatory requirements it will support the practice's MACRA reporting. 2017 will be the first time the practice has reported for any incentive programs, and Sherri is taking part in online training offered by Quest Diagnostics to prepare her to report for MACRA.
