



Quality Payment Program Eligibility assistant



In 2017, all eligible providers need to participate in MACRA's Quality Payment Program (QPP) to avoid potentially significant penalties. How will this impact your practice?

Use this assessment to learn if you need to participate in the QPP. And if so, what track you will be in—the Merit Based Incentive Payment System (MIPS) or Advanced Alternative Payment Models (APMs).

Are you a:

- Physician (Doctors of Medicine or Osteopathy, Doctors of Dental Surgery or Dental Medicine, Doctors of Podiatric Medicine, Doctors of Optometry, Chiropractors)
- Physician assistant
- Nurse practitioner
- Clinical nurse specialist
- Certified registered nurse assistant

If you are not in one of these categories, you are not eligible for the QPP.

If you answered yes to one of the above options, then answer these additional questions to see if you qualify to participate:

1. Is 2017 your first year of Medicare? Yes No
2. Do you see fewer than 100 Medicare patients each year? Yes No
3. Do you have \$30,000 or less in annual Medicare claims? Yes No

If you answered yes to any of these questions, you are excluded from participation in MACRA.

If you answered no to **all of these** questions, please continue to determine if you should participate in MIPS or Advanced APMs.

If you answered yes to **any of these**, you are in an Advanced APM.

If you receive 25% of your Medicare payments or see 20% of your Medicare patients through an Advanced APM, then you can earn a 5% incentive payment in 2019. You do not participate in MIPS.

If you answered no to the list above, then you will be participating in MIPS starting in 2017.
